The 660 MW Tanda unit is equipped with supercritical boiler manufactured by L&T -MHPS Boilers Pvt Ltd, a joint venture company of L&T and Mitsubishi Hitachi Power Systems (MHPS), Japan. The Khargone and Tanda projects are each of 2x660 MW capacity.
